Membership in the Church (A Summary of the Canons)

The National Canons address membership in the Church and the expectations the Church places on those members:

- 1. Members of the Church are those persons who have been baptized in the Name of the Father, Son, and Holy Spirit with water, and who baptism has been duly recorded in this Church. Adult members are those persons sixteen years of age and older.
- 2. All adult members of the Church are expected to be confirmed in the Church, or if they have been confirmed in another Christian Church by a Bishop in Apostolic Succession, to have been received into this Church.
- 3. All members are considered to be communicants of this Church who have received Holy Communion at least three times during the previous year in this Church.
- 4. All persons in this Church are expected to celebrate and keep the Lord's Day and participate in the Church's public worship.

Communicants in good standing are those who have:

- A. Attended corporate worship on a regular basis in their Church unless they have been prevented from doing so for good cause;
- B. Have been faithful in the giving of their time, talents, and treasure for the spread of the Kingdom of God.

Vestry Eligibility Requirements

Canon 11, Section 4.

Only lay persons, who are confirmed adult communicants in good standing of the church, as defined in General Convention Canon 1.17, shall be eligible for election as Vestry members of such church. However, regardless of eligibility of a person for election, no person shall be elected at duly convened congregational meetings to consecutive full terms on a congregation's Vestry or Vestry Committee.

Two new services of Evensong, in the spring and fall, were well received, as was the Advent service of Lessons and Carols, which was moved to an evening candlelight service for the first time at St. Mary's. The Choir performs over 100 anthems during a choir season ranging from 16th-century motets all the way through 20th-century anthems. That requires commitment from the choir, certainly, but also resources, and we are grateful to our members who, through their gifts, make possible the vestments, musical scores, as well as paid singers who fill out the four sections of the Choir.

Altar Guild

St. Mary's Altar Guild has always been a valued part of the church community. Members contribute untold hours to enhance the services at St. Mary's through the ministry of setting up the altar and communion with the church's exquisite linens and silver, as well as through arranging lovely flowers and greens on the Altar for every service. Unique to St. Mary's are the inspiring arrangements of greens and flowers that often come from members' gardens.

Currently, there are approximately 70 members of the Altar Guild serving in monthly rotations. Many of them have been on Altar Guild for decades and their gifts of time and talent are invaluable. This year workers have been responsible for all Sunday services as well as for 15 baptisms, seven weddings, and 13 funerals. Each week, members come in on Fridays or Saturdays to arrange flowers and prepare any special needs for the Sunday service. Then on Sundays, members return to finish all set-up for Little St. Mary's, as well as for New St. Mary's. Following the service, Altar Guild is responsible for cleaning up and taking down the Altar and safely storing Communion items, as well as placing the offering in the proper area.

In addition, Altar Guild members flowered the church for Easter with the loveliest of spring blooms from their gardens and at Christmas filled the church with greens and poinsettias. A new evening service of Lessons and Carols brought candlelight and greens into the windows. Also, a special Evensong earlier in the year highlighted another choir event with altar flowers and greens.

A special event was the well-attended Altar Guild dinner where Sarah Chiffriller gave a fantastic demonstration on arranging naturally on a smaller scale. Her work is inspiring!

In 2016, new purificators were ordered and a new container was made for the altar stand. Connie Martenstein has been graciously laundering and ironing so many of the linens for St. Mary's!

A parenting class based on *The Blessing of the Skinned Knee* by Wendy Mogel was well attended. Spring also brought recognition of our Sunday school teachers and committee members. New members on the Committee brought the group to a total of 16 members. Kerri White will chair the group in May 2017.

Summer brought Vacation Bible School. Seventy children registered for the week! It was busy. We were fortunate to have many wonderful adult volunteers, in addition to 20 youth who truly made the week for the kids. Many thanks to Matt Rawls and the youth group for their hard work!

This fall, 18 Sunday school teachers welcomed our youngest members into classrooms. We currently have an average attendance of 30-40 kids each week. A 5th grade only class was created this year and has a strong group of kids attending. This fall, we upgraded our nursery to a dedicated space just off the Dover Lounge. We continue to make improvements so that we are as welcoming as possible to new families.

In Advent, we continued the tradition of Advent wreath making on the first Sunday of Advent to help families celebrate the season at home. The Annual Children's Lessons and Carols remains a favorite activity for the children. This year, the service began at 4 p.m., an hour earlier than years past, but still with great attendance. We also added a "real" baby Jesus to the cast, much to the delight of the children and congregants. 2017 will be a year of continued growth for our service to children and families here at St. Mary's.

Fellowship

The Fellowship Committee is responsible for scheduling once a month breakfasts and dinners, which are held in the New Parish Hall beginning in October through May and coordinating special events for the church family. We meet on the first Tuesday each month throughout the church year, taking a break in the summer.

Breakfasts are on the second Sunday of each month from 9:30 a.m. to 10:30 a.m. Volunteers prepare the menu, cook the food, serve, and clean up. Dinners are held on the third Wednesdays of each month between 5:30 p.m. and 7 p.m. Again, volunteers prepare the menu, cook, serve, and clean up. There are usually children's events on Wednesday nights, so children friendly food is also prepared. During Lent, simple dinners are prepared each week throughout the season.

Several times during the year, a special event may require the committee to step up and prepare food for a retirement party, a special reception, a picnic, or a brunch such as when the Bishop comes for confirmation. We work with the office administrator to order food and supplies when needed and we try to keep an inventory so we are ready for monthly and special events. Our volunteers are amazing and are always there to help for whatever needs to be done.

Outreach

In the year 2016, St. Mary's Outreach Committee created and implemented a formalized grant process. There is a long-standing history of supporting local non-profits financially. However, there were no guidelines in place on when and why an organization was approved.

The institution of the grant process sought to strengthen relationships between St. Mary's and our outreach partners, as well as among St. Mary's parishioners who are involved in outreach. As the grant application read, "St. Mary's Episcopal Church evaluates grant requests from organizations with particular attention given to those institutions that serve individuals and communities of the marginalized, vulnerable, and weak in Goochland County and metropolitan Richmond. St. Mary's also seeks to support institutions that have a spiritual component, as well as those in which St. Mary's parishioners are, or can be, involved."

In addition to providing a grant application, it was required that a member of the Outreach Committee visit the site of the institution and then report back to the committee. In the long run, the new grant application process will allow St. Mary's to better understand and evaluate the needs of the institutions, as well as volunteer opportunities, and thus will enhance St. Mary's and the institution's relationship overall.

During the September 8 meeting, the committee reviewed all applications, shared information regarding the site visits, and made grant recommendations for the Vestry's approval. On September 27, the Vestry approved six grants totaling \$34,780. The recipients included CARITAS, CrossOver Healthcare Ministry, Gateway Homes, Goochland Family YMCA, Goochland Free Clinic and Family Services, Peter Paul Development Center, and St. Andrew's School.

Overall, 2016 was a growing and learning process for the Outreach Committee. The Outreach Committee looks forward to continually developing these relationships and bringing new opportunities for St. Mary's parishioners to be involved.

On top of all that, St. Mary's parishioners donated generously to a number of drives including the snack drive in October to Peter Paul Development Center, the Thanksgiving Food Drive, and the Clothes Closet drive for Goochland Free Clinic and Family Services. For Thanksgiving, the donations totaled 652 pounds of food!

Looking forward to 2017, Ashley Cameron and Chris Ritrievi are exploring a possible international mission trip opportunity to Quito, Ecuador. And St. Mary's is in conversation with St. Peter's Episcopal Church about how we can build a relationship and mutually support each other. This is a continually growing and vibrant ministry within the life of St. Mary's.

Stewardship

St. Mary's currently has \$828,507 in total pledges for 2017 with 25 new pledges and 130 households increasing their pledge from 2016. We are approximately \$96,767 behind last year's total pledges but St. Mary's 2017 budget requires another \$221,693 to be raised to meet the budgetary requirements. We are hopeful that the 88

The committee has several stewardship focused seminars planned for 2017, including next month's Legacy Giving Speaker, Deal Thompkins, from the Diocese of Virginia. In the spring, we will feature Proportional Giving - what it means for you and your family. In addition, the committee will provide a menu of capital improvements St. Mary's will need over the next one, three, and five years which will be opportunities for gifts from our Parishioners.

Youth Ministries

2016 was a big year for the youth ministries at St. Mary's! We continued to see growth in our existing programs and added new ministries.

Last May, 22 students appeared before Bishop Johnston to be confirmed into the St. Mary's community. Much to their surprise (and their parents!), the person who led them through their confirmation process, Matt Rawls, was also confirmed. It was a joyous occasion for all.

The ministries to middle school students continued to grow. Special thanks to Sara Grattan and Kerri White for helming what is often a raucous Sunday School program. Also, at the request of some of the middle school students, we now have a cooking class for a group of middle school girls. This ministry, led by two volunteers, teaches not only the fundamentals of cooking but also the spirituality of feeding oneself and others around the dinner table and every Sunday at the altar table.

2016 saw the re-birth of ministry to high school students. Thanks to help from Andy Howlett and Jesse McCoy, we now have a regularly meeting Sunday morning offering for high school students. We also have a regularly meeting Sunday evening youth group program which was kick-started by an introduction to yoga by the inimitable Sydna Street.

Looking forward into 2017, perhaps the most exciting aspect of the youth ministries at St. Mary's is the mission and service trips planned for this summer. The excitement from local service projects during the summer of 2016 led to planned mission trips a little farther afield for 2017. The high school students are going to South Dakota to serve at the Rosebud mission on the Lokata Sioux Reservation. The Confirmation class is going to New York City for service (and a little fun). The middle school students will head to Lincoln County, WV for serve the surrounding community. We expect all these trips to be impactful, not just for the communities served, but for those of us serving as well.

Financial Report to the Congregation

Global Observation: St. Mary's remains in stable financial health.

Specific Observations:

- 1. 2016 resulted in a modest surplus of \$33,000 on a Budget of approximately \$1,140,000.
 - a. Total revenues were 98% of the Forecast.
 - b. Actual expenses were roughly 96% of Budget.
- 2. The 2017 Budget is essentially a balanced budget.
 - a. The 2017 Budget was specifically prepared with an imbedded initial deficit. The amount \$30,000 is actually lower than originally forecasted when the development of this Budget began. The reason for this lies strictly in the fact that considerable, new investment in Personnel involving Church Operations was proposed and unanimously approved by both the Finance Committee and The Vestry. The long-term goal of this "investment" is to enable the Church Staff to provide greater outreach and responsiveness, among others, to the St. Mary's community. This approach was born out of the Strategic Plan and the Discernment Process and was the driving force behind this investment. The Vestry and Finance Committee agreed to support this investment up to roughly \$75,000 a year for two years of 'imbedded deficits" if necessary. Note the funds would come from our Operating Reserve, if necessary.
- 3. Combined investments collectively are greater than ever specific gifts remain the primary reason.
 - a. The Total of all 3 Non-Operating Funds is over \$2 million (\$2,040,000), an increase of \$50,000 vs. 2015 year end.
- 4. The projected "deficit" of roughly \$30,000 in 2017 will come from the Church's Operating Reserve Fund, held at SunTrust. This fund has roughly \$155,000.
- 5. The 2017 Budget still has no provision for a "Depreciation Account" to cover the Church's Capital Replacement and Renewal and Repair. (Note: Recent reports show this figure to be in the \$700,000 range.)
